MEMORANDUM FOR UNDER SECRETARY OF DEFENSE FOR INTELLIGENCE

SUBJECT: Approval of New Targeted Local Market Supplement Rates of Pay for Polygrapher Positions Covered by the Defense Civilian Intelligence Personnel System

This responds to your February 8, 2018, request to establish new Targeted Local Market Supplements (TLMS) for polygraphers in the 0080, 0132, 1801, and 1810 occupational series covered by the Defense Civilian Intelligence Personnel System, and assigned to the Washington, District of Columbia; Denver, Colorado; State of Hawaii; Los Angeles, California; or Rest of United States locality areas; and all foreign areas. The attached TLMS rates are approved and will be effective at the beginning of the first pay period following approval of this memorandum. TLMS pay rates will be adjusted automatically in accordance with paragraph 4.h. of Enclosure 3 to Department of Defense Instruction 1400.25, Volume 2006, "DoD Civilian Personnel Management System: Defense Civilian Intelligence Personnel System (DCIPS) Compensation Administration."

The new TLMS amounts will provide the Department with the pay flexibility to attract and retain the polygraph staff needed to carry out our national security responsibilities. The TLMS will be subject to annual review by the Under Secretary of Defense for Intelligence to ensure the rates are still required to meet mission requirements. This information, along with staffing data, is to be shared with my office as requested.
