## Using the Guide

Based on your role, *How Do I . . . : A Guide to Completing Key Actions in DCIPS PAA* provides step-by-step instruction for planning, managing, and rating performance. The guide is organized into eight sections:

- Section 1: Employee How Do I . . .
- Section 2: Rating Official How Do I . . .
- Section 3: Reviewing Official How Do I . . .
- Section 4: Guest Rater How Do I . . .
- Section 5: Guest Reviewer How Do I . . .
- Section 6: Trusted Agent How Do I . . .
- Section 7: Pay Pool Administrator How Do I . . .
- Section 8: Troubleshooting

For the information to be most useful to you, refer to the appropriate section as you complete key activities. Each activity begins from the MyPerformance Main Page or from the specified Navigator menu and provides the most efficient way to complete the activity.

An important reminder: Online help is available by selecting the Need Help link on each PAA page.

## Accessing the Defense Civilian Intelligence Personnel System (DCIPS) Performance Appraisal Application (PAA)

Employees and Rating Officials/Reviewing Officials can access the DCIPS PAA through "MyBiz+". To navigate to the 'MyPerformance Main Page', employees select 'MyPerformance' and Rating Officials/Reviewing Officials select 'Performance Management and Appraisal' under 'Manager Functions' **in 'Key** Services' in "MyBiz+".

If you do not have a DCPDS account to access "MyBiz+", contact your human resources administrator for assistance.

## **Important Dates**

Establish an approved performance plan: The performance plan should be completed by October 31 or within 30 days of being assigned to a DCIPS position.

Complete a Midpoint Review: The Midpoint Review is usually conducted in April, six months after the performance cycle begins. Components have discretion regarding the involvement of reviewing officials.

Complete an annual performance evaluation (Annual Appraisal - DCIPS):

• No later than (NLT) 15 days after the close of the evaluation period – Employees complete their self-assessment (also known as a self-accomplishment report) and transfer it to their rating officials.



- NLT 30 days after the close of the evaluation period Rating officials complete their recommended evaluations of record and transfer them to their reviewing officials for approval.
- NLT 45 days after the close of the evaluation period Reviewing officials approve the recommended evaluations and ratings and return the approved evaluations and ratings to rating officials, who return the approved evaluations and ratings to employees for acknowledgment. Note: The PM PRA must review the ratings before the reviewing officials return approved ratings to the Rating Official.

Complete a Closeout - DCIPS Performance Evaluation of Record (Closeout-DCIPS) — If the employee and/or rating official is changing and the change occurs before 90 days from the end of the performance cycle, a closeout evaluation of record is conducted. Consult with your Component or organization regarding specific timing requirements.

Complete a Closeout – Early Annual - DCIPS Performance Evaluation (Closeout-Early Annual-DCIPS) – If the employee and/or rating official is changing and the change occurs within 90 days of the end of the performance cycle, an early annual evaluation of record is conducted. Consult with your Component or organization regarding specific requirements.

An important note: The processing of a performance plan or an evaluation of record is sequential and ownership of the performance plan and evaluation of record passes between the employee, evaluator and reviewer. It is important to understand that changes to the performance plan or evaluation of record cannot be accomplished by any of these three who do not own the plan in the PAA.



## Section 1: Employee – How Do I . . .

An important note: The first time the 'Go' button is selected for 'Create New Plan' or 'View' or 'Update' on the *MyPerformance* Main Page, an 'Unclassified Information Only' page will display. You must agree that you will not enter any classified information by checking the box and selecting the 'Continue' button in order to continue.

Employee Performance Plan

Create or Copy My Performance Plan?

- 1. Begin at the *MyPerformance* Main Page.
- 2. Select 'Defense Civilian Intelligence Personnel System' from the 'Choose a Plan Type' drop-down menu.
- 3. Select the 'Go' link to display the Create Performance Plan: Setup Detailspage.
- 4. Review the information and make any necessary changes to the default values.
- 5. Select the 'Build New Performance Plan' link or 'Copy an Existing Performance Plan' link. An error message will be received if you are not currently assigned to a DCIPS Pay Pool.
- 6. Select one of the following:
  - Select the 'Next' link to continue the 'Build New Performance Plan' process.
  - Select the 'Find' link after entering search criteria, select the 'Copy' link for the performance plan to be copied and then confirm your wish to copy the performance plan identified by selecting 'Yes' to continue the 'Copy an Existing Performance Plan' process.
  - Select the 'Logout' link to end your session.

Add Mission/Strategic Goals?

- 1. Begin at the *MyPerformance* Main Page.
- 2. Open an existing performance plan by selecting 'Update' from the 'Action' drop-down menu for the plan and select the 'Go' link.
- 3. Select the Mission Goals tab.
- 4. Enter your organization's goals and priorities.

If information is not included about your component's goals and priorities, employees are encouraged to provide this information. It helps you write effective performance objectives that align with your component's mission goals and priorities.

You may type directly into the text box or copy and paste from another document. You may select the 'Spell Check' button to check the spelling of the text.

5. Select the 'Next' link or Performance Objectives tab to continue with the process, or select the 'Logout' link to end your session.



Add Performance Objectives?

- 1. Begin at the *MyPerformance* Main Page.
  - Open an existing performance plan.
  - Select 'Update' from the 'Action' drop-down menu for the performance plan listed.
  - Select the 'Go' link.
- 2. Select the Performance Objectives tab.
- 3. Select the 'Add Performance Objective' link to create a new performance objective.
- 4. Enter a meaningful performance objective title.
- 5. Change the start date if the default value is incorrect.
- 6. Enter your draft performance objective text. You may select the 'Spell Check' button to check the spelling of the text.
- 7. Select one of the following links:
  - Select 'Save' periodically to save the performance objective and continue writing.
  - Select 'Save and Add Another Performance Objective' to save and begin writing another performance objective.
  - Select 'Save and Return to Performance Objectives Tab' when you are finished entering performance objectives.
- 8. After you have completed adding performance objectives and selected 'Save and Return to Performance Objectives Tab,' select the 'Next' link to continue with the process, or select the 'Logout' link to end your session.

Delete Performance Objectives?

Note: You may not delete a performance objective once it is approved by your Rating and Reviewing Officials.

- 1. Begin at the *MyPerformance* Main Page.
- 2. Open an existing performance plan by selecting 'Update' from the 'Action' drop-down menu for the plan listed.
- 3. Select the 'Go' link.
- 4. Select the *Performance Objectives* tab to list your performance objectives.
- 5. Select the 'Delete' icon for the performance objective you want to delete.
- 6. Select the 'Next' link to continue with the process, or select the 'Logout' link to end your session.

Update Performance Objectives?

Note: You may not update an approved performance objective. Changes to approved objectives must be made by your Rating Official. Employees can add new performance objectives after the performance plan has been approved.



- 1. Begin at the *MyPerformance* Main Page.
- 2. **Open your current performance plan by selecting 'Update' from the 'Action'** dropdown menu.
- 3. Select the 'Go' link.
- 4. Select the *Performance Objectives* tab to list your performance objectives.
- 5. Select the 'Update' link for the performance objective you want to update.
- 6. Update any of the performance objective information:
  - Performance objective title
  - Start date
  - Performance objective text
- 7. Select one of the following links when your performance objective information is complete:
  - Select 'Save' to save the performance objective and continue writing.
  - Select 'Save and Update Another Performance Objective' to save and begin updating another performance objective.
  - Select 'Save and Return to Performance Objectives Tab' when you are finished updating performance objectives.
- 8. After you have completed updating performance objectives and selected 'Save and Return to Performance Objectives Tab,' select the 'Next' link to continue with the process, or select the 'Logout' link to end your session.

View My Performance Elements?

- 1. Begin at the *MyPerformance* Main Page.
- 2. Open your current performance plan by selecting 'Update' or 'View' from the 'Action' drop-down menu.
- 3. Select the 'Go' link.
- 4. Select the Performance Elements tab to list your performance elements.

Note: The Performance Elements are auto-populated based on the supervisory level for your position as of the Appraisal Period Start Date and cannot be changed. If incorrect, the Performance Plan will need to be deleted and a new Performance Plan created with the appropriate Appraisal Period Start Date when the supervisory level has been corrected.

5. After you have completed viewing your performance elements, select the 'Next' link to continue to the next tab, select the 'Return to Main Page' link to continue the process or select the 'Logout' link to end your session.

Transfer My Performance Plan to My Rating Official?

1. Begin at the *MyPerformance* Main Page.



- 2. Select 'Transfer to Rating Official' from the 'Action' drop-down menu for the performance plan listed. You may also transfer your performance plan to your Rating Official by selecting the 'Transfer to Rating Official' button in upper right hand corner of screen at any time during the process.
- 3. Select the 'Go' link.
- 4. Write an e-mail message to the rating official indicating that you are transferring the **performance plan. The 'Spell Check' butt**on is available to check the spelling in the email message.
- 5. Select the 'Transfer to Rating Official' link at the top of the *E-Mail Notification* page.

Acknowledge My Performance Plan?

- 1. Begin at the *MyPerformance* Main Page.
- 2. Open your current performance plan by selecting 'Update' or 'View' from the 'Action' drop-down menu.
- 3. Select the 'Go' link.
- 4. Select the Performance Plan tab, followed by Approvals & Acknowledgmentstab.
- 5. In 'Step 4: Employee Acknowledgment,' select the 'Acknowledge Receipt' link which will be available once Step 3 has been completed.
- 6. Select the 'Return to Main Page' link to continue with the process, or select the 'Logout' link to end your session.

Track Progress of My Performance Plan During the Performance Cycle?

Note: Selecting the Link in the Links column will navigate you directly to the applicable tab within the DCIPS PAA. Table 1 - Employee Track Progress Links indicates when the Links will appear.

- 1. Begin at the MyPerformance Main Page.
- 2. Open your performance plan by selecting the 'Go' link next to either 'Update' or 'View' in the 'Action' column.
- 3. Select the 'Track Progress' link.
- 4. Select the 'Return to Previous' link to continue or select the 'Logout' link to end your session.

- 6. Select 'Track Progress' from the 'Action' drop-down menu for your current performance plan.
- 7. Select the 'Go' link.

- 3. Select the 'Go' link.
- 4. Select the Midpoint Review tab.
- 5. Select the 'Create Midpoint Review' link.
- 6. Select the Performance Objective Assessments tab.
- 7. Select the radio button for the performance objective for which you want to write an assessment.
- 8. Enter your self-assessment into the 'Employee Self-Assessment' box. You may copy and paste this data into the appropriate box from MS Word or 'My Journal'. You may select the 'Spell Check' button to check the spelling of the text.
- 9. Repeat steps 7 and 8 until each assessment is complete.
- 10. Select the Performance Element Assessments tab.
- 11. Select the radio button for the performance element for which you want to write an assessment.
- 12. Enter your self-assessment into the 'Employee Self-Assessment' box. You may copy and paste this data into the appropriate box from MS Word or 'My Journal'. You may select the 'Spell Check' button to check the spelling of the text.
- 13. Repeat steps 11 and 12 until each assessment is complete.
- 14. Select the 'Return to Midpoint Reviews' link at the top of the screen when you have completed entering your self-assessment for all your performance objectives and performance elements.
- 15. Select the 'Transfer to Rating Official' link on the *Midpoint Review* tab to transfer your midpoint review to your rating official.
- 16. Type an e-mail message to your rating official requesting a review. The 'Spell Check' button is available to check the spelling in the email message.
- 17. Select the 'Transfer to Rating Official' link at the top of the *E-Mail Notification* page.

Create Self-Assessment for My Midpoint Review under the Single Assessments Option?

- 1. Begin at the *MyPerformance Main Page*.
- 2. **Open your current performance plan by selecting 'Update' from the 'Action'** drop down menu for the plan listed.

Note: The DCIPS PAA status is 'Plan Approved.'



- 3. Select the 'Go' link.
- 4. Select the Midpoint Review tab.
- 5. Select the 'Create Midpoint Review' link.
- 6. Select the Performance Objective Assessments tab.
- 7. Select the 'Show Performance Objectives' link and then the 'Show' link under 'Details' next to the 'Performance Objective', or select the 'Show All Details' link to review performance objectives.
- 8. Type your consolidated performance objectives and performance elements self-report of accomplishments into the 'Employee Self-Assessment' box. You may copy and paste this data into the appropriate box from MS Word or 'My Journal'. You may select the 'Spell Check' button to check the spelling of the text.
- 9. Select the 'Return to Midpoint Reviews' link at the top of the screen when you have completed entering your self-assessment for your consolidated performance objectives and performance elements.
- 10. Select the 'Transfer to Rating Official' link on the *Midpoint Review* tab to transfer your midpoint review to your rating official.
- 11. Type an e-mail message to your rating official requesting a review. The 'Spell Check' button is available to check the spelling in the email message.
- 12. Select the 'Transfer to Rating Official' link at the top of the *E-Mail Notification* page.

Acknowledge My Completed Midpoint Review?

- 1. Begin at the *MyPerformance* Main Page.
- 2. Open your current performance plan by selecting 'Update' or 'View' from the 'Action' drop down menu.

- 4. Select the *Midpoint Review* tab and 'Update' button, followed by *Approvals & Acknowledgments* tab.
- 5. In 'Step 4: Employee Acknowledgment,' select the 'Acknowledge Receipt' link which will be available once Step 3 is completed.
- 6. Select the 'Return to Midpoint Reviews' link to continue, or select the 'Logout' link to end your session.

Create My Self-Assessment under the Individual Assessments Option?

- 1. Begin at the *MyPerformance* Main Page.
- 2. **Open your current performance plan by selecting 'Update' from the 'Action'** dropdown menu.

Note: The DCIPS PAA status will be 'Midpoint Review Completed' or 'Plan Approved.'

3. Select the 'Go' link.



- 4. Check 'Appraisal Type' field from the Performance Plan Details tab to ensure correct type has been selected either 'Annual Appraisal DCIPS', 'Closeout Early Annual DCIPS' or 'Closeout DCIPS'. If incorrect, notify your Rating Official as the Rating Official will be able to change it once your Performance Evaluation has been transferred to the Rating Official.
- 5. Select the *Performance Evaluation* tab followed by *Performance Objective Assessments* tab.
- 6. Select the radio button for the performance objective for which you want to write an assessment.
- 7. Type your self-assessment into the 'Employee Self-Assessment' box. You may copy and paste this data into the appropriate box from MS Word or 'My Journal'. You may select the 'Spell Check' button to check the spelling of the text.
- 8. Select the Performance Element Assessments tab.
- 9. Select the radio button for the performance element for which you want to write an assessment. To provide a summary for all performance elements, enter your summary in the block for Performance Element 1.
- 10. Type your self-assessment into the 'Employee Self-Assessment' box. You may copy and paste this data into the appropriate box from MS Word or 'My Journal'. You may select the 'Spell Check' button to check the spelling of the text.
- 11. When you have completed entering your self-assessment for all your performance objectives and performance elements, transfer your performance evaluation to your rating official by selecting the **'Transfer** to Rating **Official'** link at the top of the page.
- 12. Type an e-mail message to your rating official requesting a review. The 'Spell Check' button is available to check the spelling in the email message.
- 13. Select the 'Transfer to Rating Official' link at the top of the *E-Mail Notification* page.

#### Create My Self-Assessment under the Single Assessment Option?

Note: The single assessment option does not apply to the Mock Pay Pool Info assessments within the DCIPS PAA.

- 1. Begin at the *Performance Appraisal Application* main page.
- 2. **Open your current performance plan by selecting 'Update' from the 'Action'** dropdown menu.
- 3. Select the 'Go' link.

#### Note: The DCIPS PAA status will be 'Midpoint Review Completed' or 'Plan Approved.'

- 4. Check 'Appraisal Type' field from the Performance Plan Details tab to ensure correct type has been selected either 'Annual Appraisal DCIPS', 'Closeout Early Annual DCIPS' or 'Closeout DCIPS'. If incorrect, notify your Rating Official as the Rating Official will be able to change it once your Performance Evaluation has been transferred to the Rating Official.
- 5. Select the *Performance Evaluation* tab followed by *Performance Objective Assessments* tab.

- 6. Select the Approvals & Acknowledgments tab.
- 7. In 'Step 2: Higher Level Review,' select the 'Return for Change' link.
- 8. Enter an e-mail message to the rating official explaining your request for a change. **The 'Spell Check' button is available to check the spelling in the email** message.
- 9. Select the 'Transfer to Rating Official' link.

Mock Evaluation and Rating

Review and Approve a Mock Evaluation and Rating?

- 1. Begin at the *MyPerformance* Main Page.
- 2. Since you do not have to have ownership of your employee's record to review the evaluation and mock recommended ratings, open an employee's existing performance plan by selecting 'Update' or 'View' from the 'Action' drop-down menu.
- 3. Select the 'Go' button.
- 4. Select the *Mock Pay Pool Info* tab. The performance plan must be approved before the *Mock Pay Pool Info* tab is available.

Note: The *Mock Pay Pool Info* tab will only be available from February 1<sup>st</sup> through August 31<sup>st</sup>. As the information entered in this area is strictly to support mock pay pool deliberations, the mock assessments and ratings will automatically be purged on September 1<sup>st</sup>.

- 5. Select the Mock Performance Objectives tab, the Mock Performance Elements tab and the Mock Performance Evaluation Ratings tab to view the employee's performance objectives, performance elements, and mock evaluations.
- 6. Select the Mock *Performance Objectives* tab to list the employee's performance objectives.
- 7. Select the radio button next to each performance objective to display the **performance objective, the employee's mock self**-assessment, the rating **official's mock evaluation, and the rating official's mock performance objective** rating.
- 8. Repeat step 7 until all performance objectives are reviewed.
- 9. Select the Mock *Performance Elements* tab to list the employee's performance elements.
- 10. Select the radio button next to each performance element to display the performance element, the employee's mock self-assessment, the rating official's mock evaluation, and the rating official's mock performance element rating.



- 11. Repeat step 10 until all performance elements are reviewed.
- 12. Select the Mock Performance Evaluation Ratings tab to view the mock evaluations.
- 13. Select the Mock Approvals & Acknowledgements tab.
- 14. In 'Step 4: Higher Level Review,' select the 'Approve' link.

Return a Mock Evaluation to Rating Official for Correction?

- 1. Begin at the *MyPerformance* Main Page.
- 2. Since you do not have to have ownership of your employee's record to review and approve a mock recommended rating, open an employee's existing performance plan by selecting 'Update' or 'View' from the 'Action' drop-down.
- 3. Select the 'Go' button.
- 4. Select the *Mock Pay Pool Info* tab. The performance plan must be approved before the *Mock Pay Pool Info* tab is available.
- 5. Select the Mock Approvals & Acknowledgements tab.
- 6. In 'Step 4: Higher Level Review,' select the 'Return for Change' button.

- 1. Begin at the *MyPerformance* Main Page.
- 2. Select the *Provide Guest Feedback* tab located in the upper left corner.
- 3. **Under the 'Action' column, select 'Go' next to 'Update Feedback' to display** the *DCIPS PAA Guest Rater* page.
- 4. In the *Performance Objective Assessments* tab, select the radio button next to each performance objective to display the performance objective.
- 5. Enter your evaluation in the Guest Rater Assessment text box. You may select the **'Spell Check' button to check the spelling of the** text.
- 6. Recommend a Performance Objective Rating.
- 7. Repeat steps 4 through 6 until all performance objectives are evaluated and rated.
- 8. In the *Performance Element Assessments* tab, select the radio button next to each performance element.
- 9. Enter your evaluation in the Guest Rater Assessment text box. You may select the **'Spell Check' button to check the spelling of the** text.
- 10. Recommend a Performance Element Rating.
- 11. Repeat steps 8 through 10 until all performance elements are evaluated and rated.
- 12. Select the 'Complete' button in the upper right-hand corner of the tab.

Note: Once completed, you will not be able to update your feedback unless the rating official requests your feedback again.

- 13. Enter additional information to the notification message to the rating official.
- 14. Select the 'Submit' button. You will be returned to the *Provide Guest Feedback* tab. 'Participation Status' will be updated to 'Feedback Completed' and 'Date Completed' will reflect the date.
- 15. Select the *MyPerformance* Main Page to start a new process, or select the 'Logout' link to end your session.

Provide a Guest Rating under the Single Assessment Option?

- 1. Begin at the *Performance Appraisal Application* main page.
- 2. Select the *Provide Guest Feedback* tab located in the upper left corner.
- 3. **Under the 'Action' column, select 'Go' next to 'Update Feedback' to display** the *DCIPS PAA Guest Rater* page.



- 4. In the *Performance Objective Assessments* tab, select the radio button next to each performance objective to display the performance objective.
- 5. Enter your evaluation in the Guest Rater Assessment text box. You may select the **'Spell Check' button to check the spelling of the** text.
- 6. Recommend a Performance Objective Rating for each Performance Objective.
- 7. In the *Performance Element Assessments* tab, recommend a Performance Element Rating for each Performance Element.
- 8. Select the 'Complete' button in the upper right-hand corner of the tab.

Note: Once completed, you will not be able to update your feedback unless the rating official requests your feedback again.

- 9. Enter additional information to the notification message to the rating official.
- 10. Select the 'Submit' button. You will be returned to the *Provide Guest Feedback* tab. 'Participation Status' will be updated to 'Feedback Completed' and 'Date Completed' will reflect the date.
- 11. Select *Home* to start a new process, or select the 'Logout' link to end your session.



#### Section 5 – Guest Reviewer – How Do I . . .

An important note: The first time the 'Go' button is selected for 'Update Feedback' on the Provide Guest Feedback page after selecting the Performance Management and Appraisal, an 'Unclassified Information Only' page will display. You must agree that you will not enter any classified information by checking the box and selecting the 'Continue' button in order to continue.

Provide a Guest Review?

- 1. Begin at the *MyPerformance* Main Page.
- 2. Select the *Provide Guest Feedback* tab located in the upper left corner.
- 3. Under the 'Action' column, select 'Go' next to 'Update Feedback' to display the *DCIPS PAA Guest Reviewer* page.
- 4. Select the 'Show Performance Objectives' link and then the 'Show' link under 'Details' next to the 'Performance Objective', or select the 'Show All Details' link to review performance objectives. Select the 'Show Performance Elements' link and then the 'Show' link under 'Details' next to the 'Performance Element' or select the 'Show All Details' to review performance elements.
- 5. Enter your evaluation in the Guest Reviewer Overall Feedback text box. You may select the 'Spell Check' button to check the spelling of the text.

Note: You are limited to 4,000 characters for the entire review.

6. Select the 'Complete' button.

Note: Once completed, you will not be able to update your feedback unless the rating official requests your feedback again.

- 7. Enter additional information to the notification message to the rating official.
- Select the 'Submit' button. You will be returned to the *Provide Guest Feedback* tab. 'Participation Status' will be updated to 'Feedback Completed' and 'Date Completed' will reflect the date.
- 9. Select the *MyPerformance* Main Page to **start a new process or select the 'Logout' link** to end your session.



#### Section 6 – Trusted Agent – How Do I . . .

Manage Trusted Agent Authorization allows reviewing officials and rating officials to assign a trusted agent(s) to act on their behalf within the DCIPS PAA. Authorization of a trusted agent(s) does not alleviate reviewing officials or rating officials of their performance management responsibilities to establish performance objectives and expectations and monitor, review, and evaluate employee performance.

The purpose of the trusted agent is to allow someone other than reviewing officials or rating officials to document the decisions made by the reviewing officials or rating officials.

Note: The 'Manage Trusted Agent Authorization' is accessed through 'MyBiz+'. The link appears under 'Manager Functions' for supervisors or after selecting 'CIV Rating Official' under Responsibilities. Those individuals appointed as Trusted Agents are assigned the 'CIV Trusted Agent' responsibility. The trusted agent accesses the PAA through the 'CIV Trusted Agent' by selecting the 'Acting as Trusted Agent' link. The trusted agent can document PAA decisions on multiple PAAs by selecting the 'DCIPS PAA Action(s) to Multiple Employees as Trusted Agent' link. The processing steps for documenting the PAA decisions as a Trusted Agent for RO (Rating Official) are as identified in Section 2 and the processing steps for documenting the PAA decisions as a Trusted Agent for HLR (Reviewing Official) are as identified in Section 3.

Reviewing officials and rating officials must approve all PAA activities documented by the trusted agent and route the performance plan to the next step by using one of the following methods:

• Select the 'Approve Trusted Agent Documentation' box located in the employee's PAA record under the appropriate *Approvals and Acknowledgments* tab. If the reviewing official or rating official does not have access to the PAA, the trusted agent forwards the performance plan to the next person in the chain of command to accomplish this task.

Or

• The reviewing official or rating official's signature on a copy of the performance plan constitutes approval of the action. The signed performance plan must be retained as documentation of approval.

Manage Trusted Agent Assignments

Authorize the Trusted Agent Role?

- 1. Select 'Manage Trusted Agent Authorization' link from 'Manager Functions' or 'CIV Rating Official.'
- 2. Select the 'Role' drop-down menu.
- 3. Select either Higher Level Reviewer or Rating Official.
- 4. Select 'System Type' drop-down menu.



5. Select either Self Service Hierarchy or Defense Civilian Intelligence Personnel System.

Note: If you select 'Self Service Hierarchy' as the system type, the next screen will display names of all employees in your hierarchy. If you select 'Defense Civilian Intelligence Personnel System' as the system type, the next screen will display only names of employees in your hierarchy who have a PAA in progress.

6. Select the 'Go' button.

Note: The 'Show Manage Assignment of Trusted Agent for Selected Employee(s)' link and the 'Results' table are displayed.

Show Manage Assignment of Trusted Agent for Selected Employees?

- 1. Select the 'Show Manage Assignment of Trusted Agent for Selected Employee(s)' link or the 'Results' table to expand the area to assign or terminate trusted agent assignments individually or as a group.
- 2. Select one of the following areas to update: (1) Assign Trusted Agent or (2) Terminate Trusted Agent.

Assign Trusted Agent?

- 1. Enter the Trusted Agent Name (required).
- 2. Enter Start Date (optional).

Note: This can be a future date but not earlier than the current date.

3. Enter End Date (optional).

Note: An end date can be entered to limit the assignment period. If entered, the end date cannot be less than the current date or the Start Date, whichever is more recent.

- 4. **Under the 'Select' column on the 'Results' table, select the employee(s) whom you** would like to assign as trusted agent(s).
- 5. Select the 'Apply' button.

Terminate Trusted Agent?

1. Enter End Date.

Note: The end date entered takes effect at the end of the day. Therefore, you cannot assign a new trusted agent until the day after the identified end date.

- 2. Under the 'Select' column on the 'Results' table, select the employee(s).
- 3. Select the 'Apply' button.



## Section 7 – Pay Pool Administrator – How Do I . . .

Performance Plans

Assign the Single-Assessment Option to Employees in My Pay Pool?

Note: This assessment option can be updated by the Pay Pool Administrator / Alternate Pay Pool Administrator or the Pay Pool Manager / Alternate Pay Pool Manager. You can assign the Single-Assessment Option for annual closeout and midpoint assessments.

- 1. Log into DCPDS and select your pay pool responsibility from the Navigator.
- 2. Select 'Manage Pay Pool IDs' from the menu.
- 3. On the 'Create PP ID' tab, retrieve the pay pool information for the pay pool to be updated by first pressing <F11>, then enter the pay pool ID in the 'Segment 1` field and then press <Ctrl> + <F11> to populate the form with the pay pool information.

Note: If you enter an existing pay pool ID in Segment 1 without retrieving the pay pool information first, you will receive an error message stating "you cannot create duplicate Pay Pool ID's. This (Pay Pool) already exists.'

4. Navigate to the 'DCIPS Pay Pool PAA Assessment Options' section, select the 'Performance Year' from the list of values (LOV) to identify the Performance Year for which the option becomes effective and select 'OK'. If you choose to assign the Single-Assessment Option for your Midpoints, select the 'Performance Year Midpoint Review' from the list of values (LOV) and select 'OK'. Both options can be selected with one option listed per line. Select the 'Assess Perf Objectives and Perf Elements for the Performance Eval in a Single Block' (Option 2) from the LOV for the 'DCIPS PAA Assessment Option' to use the one assessment block option for each type of assessment and select 'OK'.

Note: If you are creating a new pay pool, the Performance Year and assessment option can be entered in this section at the time the new pay pool is created. If this section is null, the Performance Evaluation screens will continue to display assessment blocks for each performance objective and performance element.

- 5. If desired, you can limit the number of characters in the Rating Official's Assessment block for all assessment types. Navigate to the 'DCIPS PAA Performance Evaluation Assessment Area' section, select the 'Character Limit' you wish to assign from the list of values (LOV) and select 'OK'. Then click on the 'Save' icon.
- 6. A 'Decision' box will then appear; select 'Yes' to continue or 'No' to cancel the update.

Note: When 'Yes' is selected, a concurrent program will be executed to update the PAA assessment option for those PAAs that have already been created for the Performance Year specified for employees in the pay pool UNLESS the PAA already contains data in the assessment blocks. If the PAA already contains assessment text in the Performance Evaluation area, then the assessment screens will continue to display the prior assessment



option for that specific PAA. Any new Performance Plans created, once the option is set, will display the Performance Evaluation assessment screens based on this option. Thus, it is highly recommended that the updating of the DCIPS PAA Assessment Option is accomplished prior to creation of the performance plans for that Performance Year.

- 6. Select the 'X' in the top right-hand corner to exit this screen.
- 7. To view the output from the concurrent program process when 'Yes' was selected, select 'View' and then 'Requests' from the top menu list and then select 'Find'. The name for this concurrent program will be 'DCIPS Update PAA records assessment option value'. To view the results, select 'View Output'. Once the output is displayed, select 'File' to save to your computer. If you save the file as 'Text', the records that were impacted can be imported into an Excel spreadsheet.

Change the Rating Official on Multiple Employees in My Pay Pool at One Time?

Note: This can be used to change the Rating Official on the Performance Plan in the **Rating Official's absence.** 

1. Select the <u>Apply Action(s) to Multiple Employees</u> link under the menu items listed on the Navigator page.

Note: This menu item is also available for the 'CIV Alternate Pay Pool Administrator' and the 'DCIPS Performance Appraisal Administrator'.

- 2. Select 'DCIPS Pay Pool Administrator' for the System and Role and then select the 'Start' button.
- 3. Select 'Change Rating Official' from the 'Available Actions' listed and then select the 'Start' button.
- 4. Enter the name for the *Current Rating Official* and then select the 'Find' button to produce a listing of employees from which to make a selection. The *Current PAA Status* and *Appraisal Year* may also be entered to limit the search results.
- 5. Select the employees to which the action should be applied and then select the **'Next'** button.
- 6. Identify the new *Rating Official;* add comments in the Notification Comments block if **desired and then click 'Save' to complete the** action.
- 7. A Status Log then appears that notifies whether or not the Rating Official was successfully updated.
- 8. Select 'Return to Available Actions' or the 'Home' link to continue or select the 'Logout' link to end your session.



Change the Reviewing Official on Multiple Employees in My Pay Pool at One Time?

Note: This can be used to change the Reviewing Official on the Performance Plan in the **Rating Official's or Reviewing Official's** absence.

1. Select the <u>Apply Action(s) to Multiple Employees</u> link under the menu items listed on the Navigator page.

Note: This menu item is also available for the 'CIV Alternate Pay Pool Administrator' and the 'DCIPS Performance Appraisal Administrator'.

- 2. Select 'DCIPS Pay Pool Administrator' for the System and Role and then select the 'Start' button.
- 3. Select 'Change Higher Level Reviewer' from the 'Available Actions' listed and then select the 'Start' button.
- 4. Enter the name of the *Current Rating Official* and then select the 'Find' button to produce a listing of employees from which to make a selection. The *Current PAA Status* and *Appraisal Year* may also be entered to limit the search results.
- 5. Select the employees to which the action should be applied and then select the **'Next'** button.
- 6. Identify the new *Reviewing Official*; add comments in the Notification Comments **block if desired and then click 'Save' to complete the** action.
- 7. A Status Log then appears that notifies whether or not the Reviewing Official was successfully updated.
- 8. Select 'Return to Available Actions' or the 'Home' link to continue or select the 'Logout' link to end your session.

Change the PAA Status on an Employee in My Pay Pool?

Note: Use caution when using this process to ensure the correct PAA is selected for the change in status. The following Current PAA Statuses can be changed through this process: 1) *Appraisal Pending HLR Approval* can be changed back to *Appraisal Returned for Change*; 2) *Appraisal Returned for Change* can be changed back to *Appraisal Pending HLR Approval*; 3) *Closed* can be changed back to the status of *Plan Approved*; 4) *Midpoint Pending HLR Approval* can be changed back to *Midpoint Returned for Change*; 5) *Midpoint Returned for Change* can be changed back to *Midpoint Returned for Change*; 6) *Plan Pending HLR Review* can be changed back to *Plan Returned for Change*; and 7) *Plan Returned for Change* can be changed back to *Plan Pending HLR Review*.

1. Select the <u>DCIPS Appraisal Administration</u> link under the menu items listed on the Navigator page.



Note: This menu item is also available for the 'CIV Alternate Pay Pool Administrator'. This process is also available for the 'DCIPS Performance Appraisal Administrator' under the <u>SuperUser</u> link.

- On the List of Plans/Appraisal page, enter the name of the Rating Official or the Employee Name or the Appraisal ID and then select the 'Find' button to locate the employee's PAA. The Current PAA Status or the Appraisal Year can also be entered to limit the search results when Appraisal ID is not entered.
- 3. **Under the 'Action' column, select 'Go' next to 'Update' for the PAA to be changed** to display the *Change Plans/Appraisals* page.
- 4. Change the *Appraisal Status* by selecting the appropriate status change allowed from the drop down list of values.

Note: The *Rating Official* and/or the *Higher Level Reviewer* can also be changed if necessary.

5. Select 'Apply' to complete the action.

Note: Ownership of the PAA is returned to the Rating Official or the Reviewing Official as appropriate based on the PAA status change.

- 6. The *List of Plans/Appraisals* page will then display. Verify that the Current PAA Status was changed.
- 7. Select the 'Home' link to continue or select the 'Logout' link to end your session.

Change the PAA Status on Multiple Employees in My Pay Pool at One Time?

Note: Use caution when using this process to ensure the correct PAA is selected for the change in status. The following Current PAA Statuses can be changed through this process: 1) *Appraisal Pending HLR Approval* can be changed back to *Appraisal Returned for Change*; 2) *Appraisal Returned for Change* can be changed back to *Appraisal Pending HLR Approval*; 3) *Closed* can be changed back to the status of the PAA prior to this status; 4) Midpoint Pending HLR Approval can be changed back to *Midpoint Returned for Change* can be changed back to *Midpoint Returned for Change*; 5) *Midpoint Returned for Change* can be changed back to *Midpoint Pending HLR Approval*; 6) *Plan Pending HLR Review* can be changed back to *Plan Returned for Change*; and 7) *Plan Returned for Change* can be changed back to *Plan Pending HLR Review*.

1. Select the <u>Apply Action(s) to Multiple Employees</u> link under the menu items listed on the Navigator page.

Note: This menu item is also available for the 'CIV Alternate Pay Pool Administrator' and the 'DCIPS Performance Appraisal Administrator'.

2. Select 'DCIPS - Pay Pool Administrator' for the System and Role and then select the 'Start' button.



- 3. Select 'Change PAA Status' from the 'Available Actions' listed and then select the 'Start' button.
- 4. Enter the name of the *Current Rating Official*, select the *Current PAA Status* from the **list of values and then select the 'Find' button to produce a listing of employees from** which to make a selection. The *Appraisal Year* should also be entered to limit the search results.
- 5. Select the employees to which the action should be applied and then select the 'Next' button.
- 6. Select the *new Rating Official PAA Status* from the list of values and then click **'Save'** to complete the action.

Note: This list of values is dependent on the Current PAA Status. If the Current PAA **Status is 'Closed', thi**s field will not appear as the new PAA Status will automatically **be set back to the status just prior to the one before the status changed to 'Closed'.** 

- 7. A Status Log then appears that notifies whether or not the PAA Status was successfully updated.
- 8. Select 'Return to Available Actions' or the 'Home' link to continue or select the 'Logout' link to end your session.

Change the PAA Appraisal Type or Appraisal Dates on an Employee in My Pay Pool?

Note: Use this process to change the Appraisal Type, Appraisal Period Beginning Date, the Appraisal Period Ending Date and/or the Appraisal Effective Date when these fields are no longer available for update by the Rating Official or the Reviewing Official.

1. Select the <u>DCIPS Appraisal Administration</u> link under the menu items listed on the Navigator page.

Note: This menu item is also available for the 'CIV Alternate Pay Pool Administrator'. This process is also available for the 'DCIPS Performance Appraisal Administrator' under the <u>SuperUser</u> link.

- 2. On the List of Plans/Appraisal page, enter the name of the Rating Official or the Employee Name or the Appraisal ID and then select the 'Find' button to locate the employee's PAA. The Current PAA Status or the Appraisal Year can also be entered to limit the search results when Appraisal ID is not entered.
- 3. **Under the 'Action' column, select 'Go' next to 'Update' for the PAA to be changed** to display the *Change Plans/Appraisals* page.
- 4. Change the following fields if appropriate.
  - Appraisal Type
  - Appraisal Effective Date



- Appraisal Period Start Date
- Appraisal Period End Date

Note: When the Appraisal Type is changed, ensure the Appraisal Period End Date is also changed. The Appraisal Effective Date can only be changed once the Reviewing Official has completed Step 2 of the '*Approvals & Acknowledgments*' for the Performance Evaluation.

- 5. Select 'Apply' to complete the action.
- 6. The *List of Plans/Appraisals* page will then display. Verify that the fields were changed to the values entered.
- 7. Select the 'Home' link to continue or select the 'Logout' link to end your session.

Close a Duplicate, Extraneous or Unfinished Performance Plan for an Employee in My Pay Pool?

Note: If the Performance Plan has been approved and the Performance Evaluation has not **been 'Approved by RO',** this can be used to close out the active PAA in the Rating **Official's or Reviewing Official's** absence.

1. Select the <u>DCIPS Appraisal Administration</u> link under the menu items listed on the Navigator page.

Note: This menu item is also available for the 'CIV Alternate Pay Pool Administrator'. This is also available for the 'DCIPS Performance Appraisal Administrator' under the <u>SuperUser</u> link.

- 2. On the List of Plans/Appraisal page, enter the name of the Rating Official or the Employee Name or the Appraisal ID and then select the 'Find' button to locate the employee's PAA. The Appraisal Year and the Current PAA Status can also be entered to limit the search results when Appraisal ID is not entered.
- 3. Select 'Close' from the 'Action' drop-down menu for the employee's performance plan to be closed.
- 4. Select the 'Go' link.
- 5. Select the 'Yes' button to continue the process when the Warning message appears.
- 6. When the Confirmation notice is received, select the 'Home' link to continue your session or select the 'Logout' link to end your session.

Delete a Pending Performance Plan for an Employee in My Pay Pool?

Note: If the Performance Plan Status is 'Pending', this process can be used to remove an erroneous PAA from the database in the Rating Official's or Reviewing Official's absence.



Use caution when using this process as the action cannot be undone.

1. Select the <u>DCIPS Appraisal Administration</u> link under the menu items listed on the Navigator page.

Note: This menu item is also available for the 'CIV Alternate Pay Pool Administrator'. This is also available for the 'DCIPS Performance Appraisal Administrator' under the <u>SuperUser</u> link.

- 2. On the List of Plans/Appraisal page, enter the name of the Rating Official or the Employee Name or the Appraisal ID and then select the 'Find' button to locate the employee's PAA. The Appraisal Year and the Current PAA Status can also be entered to limit the search results when Appraisal ID is not entered.
- 3. Select 'Delete' from the 'Action' drop-down menu for the employee's performance plan to be deleted.
- 4. Select the 'Go' link.
- 5. Select the 'Yes' button to continue the process when the Warning message appears.
- 6. When the Confirmation notice is received, select the 'Home' link to continue your session or select the 'Logout' link to end your session.

Reset PAA Status to Pending Approval by Reviewing Official when Prematurely Approved Prior to PM PRA Review for Employees in My Pay Pool?

Note: Use caution when using this process as this un-does the Performance Evaluation approvals for all previously completed approval steps 2 through 4. The following PAA Statuses can be changed through this process when the PAA identified is the most recent performance evaluation for the employee: 1) *Approved by HLR*; 2) *Approved by RO*; 3) *Closeout Approved by HLR*; 4) *Closeout in Progress*; 5) *Completed*.

1. Select the <u>DCIPS Appraisal Administration</u> link under the menu items listed on the Navigator page.

Note: This menu item is also available for the 'CIV Alternate Pay Pool Administrator'. This process is also available for the 'DCIPS Performance Appraisal Administrator' under the <u>SuperUser</u> link.

- 2. On the *List of Plans/Appraisal* page, enter the name of the *Rating Official*, the *Employee Name* and the *Appraisal Year or the Appraisal ID* and then select the **'Find' button to locate the employee's PAA. The Current PAA Status can also be entered to** limit the search results when Appraisal ID is not entered.
- 3. **Under the 'Action' column, select 'Go' next to 'Update' for the PAA to be changed** to display the *Change Plans/Appraisals* page.



- 4. Change the Appraisal Status to 'Appraisal Pending HLR Approval' for Appraisal Types 'Annual Appraisal - DCIPS' and 'Closeout - Early Annual - DCIPS' and to 'Closeout Pending HLR Approval' for Appraisal Type 'Closeout - DCIPS'.
- 5. Select 'Apply' to complete the action.

Note: Ownership of the PAA is returned to the Reviewing Official with the Status for Step 2 of the *Approvals & Acknowledgments* process changed to 'Not Started' unless the Rating Official had documented the higher level review by completing Option B in Step 1. In that case, the ownership is returned to the Rating Official with the Status for Step 1 changed to 'Not Started'.

- 6. The *List of Plans/Appraisals* page will then display. Verify that the Current PAA Status was changed.
- 7. Select the 'Home' link to continue or select the 'Logout' link to end your session.

Track Progress of the Performance Plan During the Performance Cycle for an Employee in My Pay Pool?

1. Select the <u>DCIPS Appraisal Administration</u> link under the menu items listed on the Navigator page.

Note: This menu item is also available for the 'CIV Alternate Pay Pool Administrator'. This is also available for the 'DCIPS Performance Appraisal Administrator' under the <u>SuperUser</u> link.

- 2. On the *List of Plans/Appraisal* page, enter the name of the *Rating Official or* the *Employee Name or the Appraisal ID* and then select the 'Find' button to locate the employee's PAA. The *Appraisal Year and the* Current PAA Status can also be entered to limit the search results when Appraisal ID is not entered.
- 3. Select **'Track Progress' from the 'Action' drop**-down menu for the **employee's** performance plan to be tracked.
- 4. Select the 'Go' link.
- 5. Select the 'Return to Previous' link to continue your session or select the 'Logout' link to end your session.

Transfer a Performance Plan from an Employee in My Pay Pool to the Rating Official?

Note: When a Performance Plan is created by the employee and the plan has never been transferred to the Rating Official, this can be used to transfer the Performance Plan to the Rating Official in the employee's absence. Current PAA Status will be 'Plan in Progress'.

The** Appraisal Year and the Current PAA Status can also be entered to limit the search results when Appraisal ID is not entered.
- 3. Select 'Transfer to Rating Official' from the 'Action' drop-down menu for the employee's performance plan to be transferred.
- 4. Select the 'Go' link.
- 5. When the Confirmation notice is received, select the 'Home' link to continue your session or select the 'Logout' link to end your session.

8. Select the 'Home' link to exit this page or select the 'Logout' link to end your session.

Print a Performance Evaluation for An Employee in My Pay Pool or for An Ex-Employee?

1. Select the <u>DCIPS Appraisal Administration</u> link under the menu items listed on the Navigator **page.'** 

Note: This menu item is also available for the 'CIV Pay Pool Manager', 'CIV Alternate Pay Pool Manager', and the 'CIV Alternate Pay Pool Administrator'. This process is also available for the 'DCIPS Performance Appraisal Administrator' under the <u>SuperUser link</u>.

Important Note: When an employee separates, the employee becomes an 'Ex-Employee' and is no longer connected to the pay pool. Therefore, the printing of a Performance Evaluation for an ex-employee can only be accomplished by the DCIPS Performance Appraisal Administrator.

- 2. On the List of Plans/Appraisal page, enter either the Employee Name or the specific Appraisal ID and then select the 'Find' button to locate the employee's PAA. The Appraisal Year and the Current PAA Status can also be entered to limit the search results when entering the Employee Name.
- 3. **Under the 'Action' column, select 'Print' for the Performance Evaluation to** be printed.

Note: The Current PAA Status must be either 'Approved by RO' or 'Completed' for the 'Print' option to appear.



- 4. Click the box to the left of 'Select/Deselect All' to view/print both the evaluation and the guest feedback or click the box to the left of 'DCIPS Closeout or DCIPS Performance Evaluation' to view/print only the DD Form 2906D.
- 5. Select 'View/Print Selected Sections' button in the lower right hand corner of screen to view and/or print the report.
- 6. Select the 'Return to Main Page' link to continue your session or the 'Logout' link to end your session.

Delegate Trusted Agent Assignments

Delegate Trusted Agent Authorization allows the pay pool administrator, in the absence of the Rating Official or Reviewing Official, to assign a trusted agent(s) to act on their behalf within the DCIPS PAA. Authorization of a trusted agent(s) does not alleviate reviewing officials or rating officials of their performance management responsibilities to establish performance objectives and expectations and monitor, review, and evaluate employee performance.

Assign or Terminate a PAA Trusted Agent Authorization on behalf of the Rating Official and/or Reviewing Official for Employees in My Pay Pool?

1. Select 'Delegate Trusted Agent Authorization' link from 'CIV Pay Pool Administrator'.

Note: This menu item is also available for the 'Alternate CIV Pay Pool Administrator' and the 'DCIPS Performance Appraisal Administrator'.

- 2. Enter the Rating Official's or Reviewing Official's name or use the Magnifying Glass icon to search for the name on the Rating Official/Higher Level Reviewer Search page.
- 3. Select the 'Find' button.
- 4. **Select the 'Go'** button under the Action column to the right of the Name for whom the trusted agent authorization is being delegated on their behalf.
- 5. Select the 'Role' drop-down menu.
- 6. Select the appropriate role; i.e., Higher Level Reviewer or Rating Official.
- 7. Select 'System Type' drop-down menu.
- 8. Select either Self Service Hierarchy or Defense Civilian Intelligence Personnel System.

Note: If you select 'Self Service Hierarchy' as the system type, the next screen will display names of all employees in their hierarchy. If you select 'Defense Civilian Intelligence Personnel System' as the system type, the next screen will display only names of employees in their hierarchy who have a PAA in progress.

- 9. Select the 'Go' button.
- 10. Select the 'Show Manage Assignment of Trusted Agent for Selected Employee(s)' link or the 'Results' table to expand the area to assign or terminate trusted agent assignments individually or as a group.



11. Select one of the following areas to update: (1) Assign Trusted Agent or (2) Terminate Trusted Agent.

Assign Trusted Agent?

- 1. Enter the Trusted Agent Name (required).
- 2. Enter Start Date (optional).

Note: This can be a future date but not earlier than the current date.

3. Enter End Date (optional).

Note: An end date can be entered to limit the assignment period. If entered, the end date cannot be less than the current date or the Start Date, whichever is more recent.

- 4. **Under the 'Select' column on the 'Results' table, select the employee(s) whom** you would like to assign as trusted agent(s).
- 5. Select the 'Apply' button.

Terminate Trusted Agent?

1. Enter End Date.

Note: The end date entered takes effect at the end of the day. Therefore, you cannot assign a new trusted agent until the day after the identified end date.

- 2. Under the 'Select' column on the 'Results' table, select the employee(s).
- 3. Select the 'Apply' button.



### Section 8 – Troubleshooting

#### Employees

I have tried to update my performance objectives, and I am unable to make changes to them in the Performance Appraisal Application.

More than likely, you do not "own" your performance plan. To make any changes, you must have "ownership." You can tell if you "own" your performance plan if on the *MyPerformance* Main Page your name is shown in the 'Current Owner' column. If you do not own your performance plan, ask your rating official to transfer your performance plan to you as follows:

- 1. Begin at the *MyPerformance* Main Page.
- 2. Select 'Transfer to Employee' from the 'Action' drop-down menu for the performance plan listed.
- 3. Select the 'Go' link.
- 4. Write an e-mail message to your employee indicating that you are transferring the performance plan.
- 5. Select the 'Transfer to Employee' link at the top of the *E-Mail Notification* page.

Note: An employee cannot make changes to approved performance objectives.

I created my performance plan, and my rating official cannot make any changes.

In order for your rating official to take any action on your performance plan, it must be transferred to your rating official. Check the *MyPerformance* Main Page to determine who **"owns" your plan. If 'Update' appears in the 'Action' drop**-down menu next to your performance plan, you still own it, so you need to transfer it as follows:

- 1. Begin at the *MyPerformance* Main Page.
- 2. Select 'Transfer to Rating Official' from the 'Action' drop-down menu for the performance plan listed.
- 3. Select the 'Go' link.
- 4. Write an e-mail message to your rating official indicating that you are transferring the performance plan.
- 5. Select the 'Transfer to Rating Official' link at the top of the *E-Mail Notification* page.

I have a performance objective that I want to delete, and the system will not let me delete it.

You may only delete a performance objective that you created if your performance plan has not been approved. Once your performance plan is approved, only your rating official can delete a performance objective.



My rating official has changed, and DCIPS PAA will not allow me to change the name to my new rating official.

The only time you can change the name of your rating official is when you create your performance plan. If you have a new rating official after your performance plan has been transferred to the former rating official or after your performance plan is approved, only your former rating official, your Pay Pool Administrator or the DCIPS Performance Appraisal Administrator can make the change. This is also true if the reviewing official changes.



Rating Officials

I submitted a request form to establish an account, but I cannot access MyBiz+.

Each Component has established procedures for accessing MyBiz+. Check with your human resources administrator for assistance. This process applies to civilian and military rating officials and reviewing officials.

I am a civilian supervisor, and I cannot obtain a MyWorkplace responsibility.

Only civilian employees with a designation of supervisory code 2 or 4 have a MyWorkplace responsibility. If you are expected to rate an employee and do not have a supervisory code 2 or 4, your human resources administrator must **assign the 'CIV Rating Official' responsibility** to you. Once this is assigned, you can perform every activity associated with managing employee performance except building a performance plan.

My employees do not show up in DCIPS PAA when I access the PAA through MyPerformance Main Page.

Check with your human resources administrator to ensure that the hierarchy of your organization is correct.

### I reviewed my employee's performance plan, and I want to make changes.

For you to take any action on your employee's performance plan, it must be transferred to you. Check the *MyPerformance* Main Page to determine who "owns" the plan. If 'View' appears in the 'Action' drop-down menu next to the performance plan, your employee still owns the performance plan. To retrieve the performance plan from your employee:

- 1. Begin at the *MyPerformance* Main Page.
- 2. Select 'Retrieve' from the 'Action' drop-down menu for the performance planlisted.
- 3. Select the 'Go' link.

I have a new employee who transferred from another Component. The new employee does not show up in DCIPS PAA through MyPerformance Main Page.

Check with your human resources administrator to ensure that the employee has been added to your organization's hierarchy.

Reminder: When a DCIPS employee transfers from one DCIPS organization to another DCIPS organization, the former rating official should complete:

• A closeout assessment, if the transfer occurs prior to 90 days of the end of the rating cycle

Or

• An early annual appraisal, if the transfer occurs within 90 days of the end of the rating cycle



When an employee arrives at his or her new location, a new performance plan should be created within 30 days.

I have an employee who transferred to another DoD Component. I completed the appropriate closeout; however, it was not documented in DCPDS prior to the personnel action being processed so the employee was an ex-employee at the time it was completed. I need to get the completed performance evaluation transferred to the **employee's new organization**.

As the Rating Official, you will need to complete 'Step 4: Rating Official Document Employee Acknowledgment' in the 'Approvals & Acknowledgments' tab for the Performance Evaluation for the employee since the employee no longer has access to the Performance Evaluation. If the Performance Evaluation was transferred to the employee when you completed 'Step 3: Rating Official Document Communication to Employee', you will need to 'Retrieve' the Performance Evaluation in order to complete Step 4.

Once Step 4 is completed, the Performance Evaluation snapshot will be created and the post CAO/Transfer process will then automatically transfer the Performance Evaluation to the gaining region if the employee was gained through the CAO/ Transfer Request process. If the employee was not gained through this process, the DCIPS Performance Appraisal Administrator on the gaining region can use the DCIPS 'Transfer PAA Request' process to transfer the employee's Performance Evaluations.



**Reviewing Official** 

I have reviewed an employee's performance plan, and there are several changes I want made before I will approve the performance plan. The rating official indicates that no action can be taken on the employee's performance plan when accessing DCIPS PAA through the MyPerformance Main Page.

- 1. You must transfer the performance plan to the rating official so that the rating official can make your requested changes. To do so:
- 2. Begin at the *MyPerformance* Main Page.
- 3. Open an employee's existing performance plan by selecting 'Update' from the 'Action' drop-down menu.
- 4. Select the 'Go' link.

Note: The DCIPS Current PAA Status is 'Plan Pending HLR Approval.'

- 5. Select the Approvals & Acknowledgments tab.
- 6. In 'Step 2: Higher Level Review,' select the 'Return for Change' link.
- 7. Enter an e-mail message to the rating official explaining your request for changes.
- 8. Select the 'Transfer to Rating Official' link.
- 9. Select 'Logout' to exit DCIPS PAA.
